### **REFEREES' MESSAGEBOARD**



#### **New Respect Referee Guide**

A newly updated version of the Referee's Guide to Respect is now available on TheFA.com. Printed copies are being made available to your Referee Development Officer at your local County Football Association. The Guide covers all the practical measures that should be put in place by clubs and leagues which have signed up to the Respect programme. It also covers your responsibilities as a referee when officiating in a Respect league.

A key aim of the Respect programme is to address abuse to referees, so we recommend you look at this Guide and if available, book onto a free Respect training session with your County FA.

#### **Monitoring Respect**

Damon Colvin circulated to all referees' guidelines in relation to the monitoring of the programme. So that Damon has an audit trail and can report to the Management Committee that ALL referees have received the guidance he has asked for acknowledgments. Unfortunately I am advised that the following officials have not responded to their correspondence – Gary Allen, Neil Conlon, David Cronk, Peter Cruise, Michael Filmer, Mark Foley, Peter Gill, Simon Haydon, Vince Kennedy, Karl May, Scott Petts and Christopher Price. Can I ask these officials and anyone who has not received the information from Damon to contact him asap.



### **Respect Handshake**

It has come to the Leagues attention that some referees' are failing to ensure that the Respect Handshake is not being undertaken before fixtures in this competition. I have received reports from assessors, clubs and even match officials.

I must make it quite clear, this is not a 'will you do it' it is 'it will be done'. Any referee reported to me for failing to apply this programme will be immediately removed from the League Panel. A decision I will not take lightly as we battle week in week out to get all our appointments covered. The one or two who are not are letting the majority down. Please comply with the Leagues instructions.

### **Match Expenses**

Please ensure that you are fully aware of the competition rules around match expenses. Clubs quite rightly watch their expenditure and do raise queries with some of the claims. It is embarrassing when we claim the wrong amount.

### **Foul Language / Dissent**

A key aim of the Respect programme is to address abuse to referees and it is becoming quite frequent this season where clubs are raising their concerns around foul language and dissent being allowed towards match officials. I realise we will never eradicate this from the game but we need to make it easier for the next official who comes along. We have a very diverse panel of referees', many experienced but quite a few newer officials who are building their careers and experience. Please carry out the 'Laws of the Game'.

I realise it has been a bag of moans this time, but the majority of you are doing a fantastic job, yes we're not always going to get it right but in the main the comments from clubs are positive.
